2. Good News and Progress in our Schools

Dr. Lishak acknowledged and thanked all of the teachers in the South Plainfield School District for all of their hard work and dedication. She said that she knows the difficult job they have each and every day but they all work for the students to ensure they have the best possible opportunities to be successful in and out of the classroom. As a teacher, you are a mentor, a leader, and at times, a parent but you always advocate for your students. Teaching is the only profession that you can say you build the foundation for all other professions. Dr. Lishak thanked the teachers for all that they do.

Dr. Lishak reminded the public to please log on to the district website and vote for your favorite tiger logo finalist. The seven finalists, one from each school, is listed on the website. Next, Dr. Lishak reported that she, along with the district principals, and Captain Seidenberg, walked the buildings last week to review the district safety protocols as well as the individual school facilities. We will continue to work with the South Plainfield Police Department to ensure the safety of all of our students and faculty. We are planning a joint safety meeting prior to the opening of school for

the 2018-2019 school year to inform the parents and community of our security plans as we move forward.

Dr. Lishak reported that testing is continuing throughout the district. Grant completed their Science testing yesterday and today. Middle School testing will take place on May 14<sup>th</sup>-15<sup>th</sup> and High School testing will be on May 17<sup>th</sup>-18<sup>th</sup>. AP testing at the High School will conclude on May 18<sup>th</sup>.

Dr. Lishak reminded the public that Franklin School is having their Mother's Day flower sale tomorrow and Friday.

Riley School sent their kindness cards to local nursing homes and hospitals on April 24<sup>th</sup> to help brighten someone's day. Riley School held its first career day on May 8<sup>th</sup>. The counselor invited parents, local business owners and community members to speak to our students about their jobs.

As a reminder, the World Language and National Honor Society Induction Ceremony will take place here at the High School on May 17<sup>th</sup> at 6:00 p.m. The Gold Card picnic will be held on June 1<sup>st</sup> from 10:00 a.m. – 1:15 p.m. here at the High School. The Hall of Fame luncheon will be held on June 5<sup>th</sup> at 11:30 a.m. at Flannigan's. The Senior Scholarship Program will be held at 6:00 p.m. that evening.

3. Presentation of District Wellness Annual Progress Report

Mr. Fried reported that the newly formed wellness committee met four times this school year to discuss the district's food service program, health and physical education programs and the district's current wellness policy. In exploring the statutory requirements set forth by the Federal Government for wellness and the components that must be in our wellness policy, Mr. Fried said that he is happy to say that our district is fully compliant with all of the items that must be in our district wellness policy.

To assess our individual school compliance with our wellness policy, the wellness committee members developed a 26 question survey that was given to each principal. The survey is a summary of all of the items in our wellness policy and a blank example of the survey can be found on the district website. The results of the survey are:

Franklin – 80% compliant  
Kennedy – 80% compliant  
Riley – 60% compliant  
Roosevelt – 85% compliant  
Grant School – 68% compliant  
Middle School – 72% compliant  
High School – 69% compliant

In future wellness committee meetings we will try to target the areas in which the schools were not compliant and work toward a goal of 85% compliant for all schools. XI. PRESENTATION OF COMMITTEE REPORTS

Buildings & Grounds

Mr. Giannakis said that there is a Buildings and Grounds Committee meeting scheduled for next Tuesday.

Curriculum

Mr. Pennisi said that they did not have a meeting due to testing in the district.

Finance

Mr. Giannakis said that there is a Finance Committee meeting scheduled for next week.

Policy

Mr. Pennisi said that the committee reviewed the section on children who anticipate moving to or from the district. The committee is recommending requiring the student to be domiciled in the district before enrolling. He reported that Dr. Lishak said that there is currently a problem with allowing students of parents who have a contract that says they are moving in. Currently, we allow students enroll up to six months before. Dr. Lishak is finding that they give us that paperwork and then it doesn't close within the six months so the committee is recommending to change the policy right to the letter of the law which means they have to be domiciled in the district.

Mr. Pennisi also reported that a policy alert was just received from Strauss Esmay so the Superintendent hasn't been able to review it and we will address those policies next month.

Mr. Pennisi said that Dr. Lishak was looking for us to implement a policy on videotaping student-teacher lessons. Currently, there is a new law or a requirement for student teachers to film three lessons and it has to be sent to Pearson in order for them to meet the requirements for them to be able to get their certificate. This is not something that we do, it is Statewide but we do not have a policy on that. Mr. Pennisi said that he asked the Superintendent to look at Strauss Esmay and Strauss Esmay returned and said we don't really have one but these are the things you should be concerned about or the things you should ask your attorney to look into and develop one for your district. We are going to be looking into that. If we don't have that policy, we don't allow it then we can't have any student teachers in the district again so it is really that you have your hands kind of handcuffed. It's either not giving these kids a chance to be in the district and some of them we hire afterwards. This is state-wide and it's not just for us.

Public Relations

No report at this time.

### Shared Services

Mr. Cassio reported that there was a meeting on May 2<sup>nd</sup>. He was in attendance with Dr. Lishak, Mr. Chapman, Mr. Both, Council President Bengivenga and Mr. Cullen. Multiple topics were discussed, including possibly getting two more SRO officers for the upcoming school year. He will have more information at the next meeting.

Mr. Cassio reported that they also discussed the paving in front of Grant School which will be taken care of this summer. The town will put in some new crosswalks out in front as well as some handicapped sidewalks.

Mr. Cassio said that Dr. Lishak, along with the South Plainfield Police Department, was evaluating the bulletproof films for the vestibules in the schools. Dr. Lishak is obtaining quotes at this time and they are discussing the effectiveness of this product and she will be following back with us on that topic.

The lit crosswalk at Maple was approved by the County and the paperwork is now in the hands of the town. Mr. Cassio said he has a meeting this Friday with the town engineer and a couple members of Council to discuss getting this taken care of.

Mr. Cassio reported that the major roads that will be paved this summer are Cedarbrook Avenue, Kenyon Avenue, Plainfield Avenue, and Morris Avenue. All the crosswalks will be replaced after the paving is completed. We have a meeting next week for the Buildings and Grounds Committee at Jost Field to go over some of the referendum projects are being done at the field, including the field house.

### Special Education

Mr. Both and Mrs. Boyle confirmed that there is a meeting scheduled for May 16<sup>th</sup>.

### Traffic Liaison

### SEPAC Liaison

Mr. Both said that the new members are in the process of changing over. They attended a SPAN meeting earlier this month. The committee seems to be going in the right direction. A meeting will be scheduled for next month.

### Legislative Liaison

Mrs. Boyle said that she was in Trenton on Saturday. They discussed that there are over 125 religious holidays that are designated by the State of New Jersey which means that if the students are absent for those holidays they do not count as an absence.

They also discussed the science assessment which was moved from 4<sup>th</sup> grade to 5<sup>th</sup> grade. Mrs. Boyle said that she asked the Governor to take into consideration that testing time

was increased from two days to four days and that takes away from time in the classroom.

Mrs. Boyle said that she reviewed a letter from New Jersey School Boards that is being sent to the Department of Education requesting a detailed explanation of the three components of HIB. Mainly, the bullying component. Boards of Educations must hear appeals on the HIBs when students are charged with HIBs but there is no bullying component to the HIB.

The Pass the Trash bill was signed by the Governor on April 11<sup>th</sup>. This bill allows a district to review 20 years back into an applicant's background. The paper trail needs to be documented and if there is a false or unfounded accusation then that doesn't have to be reported. The bill deals with abuse and/or sexual charges against students and staff.

Mrs. Boyle also reported that there was a discussion on health care benefits for teachers and staff. It was reiterated that the benefits must be the same or greater. The Janice vs. AFSCME is on Governor Murphy's desk. This bill consists of multiple provisions for the association for the use of the facilities, use of e-mail system allowing part time employees to join the union, allowing employees to opt out of joining the union and paying dues which allows your employee to opt out 10 days after their anniversary. This is on Governor Murphy's desk waiting to either be signed or not signed.

Mrs. Boyle said that they have been advised not to include the funding that all of the districts have been quoted because that amount can change. The State's budget is July 1<sup>st</sup> and if anyone want to look at the school funding formula for each town its [drgreenenewton.blogspot.com](http://drgreenenewton.blogspot.com).

There is a bill that is authorizing one billion dollars in state general obligation bonds to be used for the county vocational tech schools and county colleges. This bill is going to be on the November ballots for the public to vote on.

Mrs. Boyle said that at the county meeting she thanked all our teachers and our nurses for all that they do. One of her guest speakers was United Way. Mrs. Boyle said that she is going to provide information to Dr. Lishak. There are multiple grants available. Johnson and Johnson is one of their multiple sponsors. Jamesburg just received \$92,000 to fund their preschool tuition. They also received \$50,000 for their public library.

As discussed last month, rather than approving the committee minutes at the next meeting we are going to have a vote to approve the presentations in the committee reports.

## XII. PUBLIC COMMENTS

Philip DeFort, 2051 Greenwich Street said that the auditorium at South Plainfield High School is home to many of the district's plays, musical performances, and ceremonies that currently serve around 1200 students. The space has become outdated and is in need of updating. The primary areas for updating in the auditorium are in need for a better house system, updated access points for concerts play and other events. A dedicated sound booth for running sound and lights and antennae for wireless microphones for better connectivity. In the current setup, all music events require that microphones and extra amplification require that a separate sound will be brought out into the middle of the auditorium and separate speakers up at the front of the stage. Cable must be run from those speakers to the sound board in the back, running across those aisles and taking away from the professional aesthetic of the room. The sound board that is set up on a folding table is currently out of date and failing. The existing Yamaha 24 channel soundboard is also losing its capability and causing added stress to any event. There is an alternate soundboard that is kept upstairs in the sound booth that is unusable as a backup. The connectivity issue in the room involves a lack of microphone hookup points in the front of the stage. The current white panel that is there only connects to the outdated band sounding house system and does not allow for connections to any outside system. To combat this issues for concerts and plays the music department has purchased several extension cords for the microphones to plug into. These cords run from the soundboard in the back of to the front of the room for the microphones to connect into. They are fully functional but clutter up the floor in the room and cause concern with cables running everywhere causing wear and tear on the device. Mr. DeFort said he would like to please ask the Board to dedicate any available funds that may be in the referendum to updating the auditorium. Thank you.

Mr. Seesselberg thanked Mr. DeFort for speaking about that and he wanted to say that he is personally involved with that auditorium over the years and it's been a problem. Mr. Seesselberg said that he did pass along to Mr. Wiggins a possible vendor but over the years we have gotten quotes in there and it's just been put by the wayside and he said that he understands the trauma for putting a show on in there. Mr. Seesselberg said that he has seen other high schools. He saw Into the Woods this year at Franklin High School and they have an excellent system.

Mr. Seesselberg said that if there is a way to do it, then we will find a way to do it. He said that he is not saying it's going to be done but it is a concern and a lot of us are aware.

Dr. Lishak said that our Supervisor of Buildings and Grounds Maintenance, Mr. Wiggins, is collecting quotes for a repair of the system and a complete replacement of the system.

If we are looking at doing that, it won't be coming from the referendum money, it would come from local funds. Referendum money is allocated to projects that the Board approved and the State approved. Dr. Lishak said that she believes that it was Mr. DeFort's dad that spoke at the last meeting and Mr. Wiggins was already collecting quotes. Dr. Lishak said that she was at the plays both last year and this year and you are sitting there enjoying the play and all of a sudden it is gone, you can't hear anything. Dr. Lishak said that we do recognize that there is a problem and we are currently collecting the quotes and moving any funds that we have because we do know it has to be addressed.

### XIII. BOARD MEMBER COMMENTS

Mr. Giannakis congratulated our softball coach, Don Panzarella. He is now the winningest softball coach in the State of New Jersey and that is a tremendous accolade. Congratulations to him and to the softball team because they have been so successful through the years.

Mrs. Boyle said that she thinks what Mr. DeFort was asking for is that if there is any referendum funds leftover they would like for us to use that for the auditorium. She said that we've all witnessed the sound system and the speakers and hopefully we will be able to fix that. She said that she knows that there is also a major concern for the kitchen so if there is anything available for that with the leftover referendum money.

Dr. Lishak said that it is her understanding that the referendum money can be used to expand on projects that were already in the referendum. So if additional work needs to be done at the field, if additional work needs to be done we can't just take it and then use it anywhere. In the referendum there is nothing that addresses the auditorium or sound system or the kitchen so therefore that would have to come from local funds. Mr. Roselle said that it doesn't mean we can't address it. Mrs. Boyle said okay because it was originally put in, the sound system was put in and then it was taken out. Mrs. Boyle said that she hopes we can find the funds to do that.

Mrs. Boyle offered condolences to Mrs. Publick on the passing of her father-in-law. She also said that the Grant School along with Mrs. Stacio and her co-director did an amazing job with their play. Every student that joins the drama club is always welcomed and there is always a spot that is found for them. Mrs. Boyle said that the Middle School play was very unique and student-driven. She congratulated Mrs. Bennet and Mrs. Philips.

Our Autism Awareness event hosted by the Mayor's Wellness Committee and the library was well attended by children in our district. Mrs. Boyle thanked Mohn's Florist for all of her donations including 100 blue balloons, string and helium tank as well as the water and treats that they provided. She also thanked Mayor Anesh for his Autism Awareness Proclamation. Mrs. Boyle said that the Mayor's Wellness Health Fair was also well-attended by doctors and residents.

The Music Booster Zumbathon will take place on May 18<sup>th</sup> as a fundraiser and the

Cultural Arts Commission will also participate in the District Art Festival which is also May 18<sup>th</sup>.

Mrs. Boyle wished Christine Heim a full recovery.

On May 25<sup>th</sup>, Riley School will have their annual walk to fight against cancer. June 2<sup>nd</sup> is the South Plainfield High School PTO merchandise bingo and mini tricky tray. The doors open at 6:00 p.m. and the tickets are on sale now. Any senior parents who would like to donate as they have done in the past is welcome to join in. June 7<sup>th</sup> is the Senior Letter Winner dinner at the Pines and the Super 50/50 that's been run by the Athletic Boosters is supporting this dinner.

Mr. Seesselberg said that he went to the Grant School show and he thinks that everybody in Grant School was involved in that somehow. The stage crew alone was 40 kids. It was a wonderful show and the teachers over there do a great job. Mr. Seesselberg thanked the teachers this week for Teacher Appreciation Week as well as every week that they are here working with the students and making South Plainfield one of the best places for schools. Voting for the press box logo is going on now on the district website. The kids are so talented and some of the things are brilliant. This will be on the press box which will be there the first football game this fall so please go and vote for your favorite.
