The law of New Jersey pursuant to R.S.2A: 111-1 provides that any person who knowingly and with intent to defraud any other person, obtains any money, property security, gain, benefit, or any other thing of value by reason of the false promises, statement, representations or writing, shall be **guilty of a misdemeanor**. The law further provides, pursuant to R.S. 2A: 85-7, that the penalty for a misdemeanor shall be a fine of not more than \$1,000 or imprisonment for not more than three years, or both.
